



**WWF Earth Hour Sign-up competition 2022
(Shape our Future)**

1. Entrants

- 1.1 The Competition is open to all residents of South Africa.
- 1.2 Directors, members, partners, agents, consultants, tenants or employees of WWF-SA, and their immediate family members are not eligible to enter this competition.
- 1.3 This competition will not be open to persons under the age of 18.

2. Term

- 2.1 The competition opens on **7 March 2022** and closes at midnight on **25 March 2022**.

3. The Prize

- 3.1.1 The Prize is 5 x WWF-SA Shop Voucher total value of R1000 each, to be awarded as set out in clause 5 below.
- 3.2 The Prize includes postage to the entrant's given address, provided such address is in South Africa. The winner must provide identification sign on receipt of the Prize when it is delivered.
- 3.3 In the event that the Prize specified in the Competition becomes unavailable for any reason, WWF-SA may substitute a Prize of like or equal value.

4. Entries

- 4.1 Entrants may enter and stand a chance to win the competition by completing the Sign up form on WWF's website (https://www.wwf.org.za/earth_hour/) and providing their first name, surname, email address.
- 4.2 Entrants may only enter the competition once.
- 4.3 WWF-SA takes no responsibility for any inability of an entrant to enter, complete, continue or conclude the competition due to equipment or technical malfunction, busy lines, inadvertent disconnection or otherwise.
- 4.4 By entering this competition, the entrant accepts the full terms, conditions and rules of this competition and agrees to abide by these rules and any requirements and/or proceedings issued by WWF-SA in regard to the competition.

5. The Winner

- 5.1 The Prize will be awarded to **5 (five) entrants drawn at random** (overseen by an independent auditor), by **the Executive Manager of Communications, WWF South Africa**, and the Winners will be notified by WWF-SA via email within one month of the

Prize draw. If the email address provided by the entrant is not valid, he/she will forfeit the Prize, and another winner will be selected on the same basis.

- 5.2 The results of the competition will be verified by an independent auditor selected by WWF-SA.
- 5.3 The Winners will be announced by 31 March via email and may be invited to be photographed, interviewed or participate in other marketing activity by WWF-SA. The Winner has the right to decline such invitation.
- 5.4 The Winner accepts the Prize entirely at his/her own risk and indemnifies WWF-SA in respect of any claim for any accident, injury, or property damage that may occur in connection with the Prize to the fullest extent allowed by law.
- 5.5 The Prize is exclusively for the Winner and is neither transferable nor exchangeable for cash or another Prize and must be accepted by the Winner within **one month** of being notified of winning the Prize or he/she will forfeit the Prize.
- 5.6 Where a diligent attempt to contact the Winner fails or the winner elects not to take the Prize or is unable to take the Prize for whatever reason WWF-SA reserves the right to either select another Winner or not award a Prize at all, in its sole discretion.
- 5.7 If, after notification, the Prize is not collected or receipt of it taken within one month of the winner being announced, it will be regarded as forfeit.
- 5.8 By entering this competition, the Entrant acknowledges that their personal information will be shared with the Promoter and its agents to the extent necessary to conduct the competition and for prizes to be delivered to winners.
- 5.9 By entering this competition and submitting your personal information, you authorise the Promoter to process your personal information in accordance with South African data protection and customer protection laws.
